## Dear Edendale Parents 30 July 2018

“Thank you to all the parents that have committed to paying their fees on time month after month. Your commitment has ensured the success of fulfilling our dream of giving good quality education to our learners”.

Over many years the School experienced the recovery of bad debt as one of our biggest challenges. With thorough investigation it became clear that the big challenge appears to emanate from the fact that parents start paying school fees at the end of January and not the beginning of January as required. Payments are therefore always one month behind. We understand that parents have many expenses over the festive season and we believe that we figured out the solution to this challenge.

**For 2019 School fees will be payable over 11 months. Parents will start paying from January until November each year. School fees for 2019 has already been finalized and approved by the board of directors and at the parents meeting held on 21 July 2018.**

**Re-registrations will open every year on 1 September until 30 November.** Communication will go out where parents need to check and change their existing personal information on the system. This form will also be signed by the parents to renew the existing contract for the next year. **Administration fee for the following year is payable between 1 September and 30 November of each year. Administration fee is compulsory for the following year.** It helps us to plan for textbooks, additional educators, support staff and facilities for 2019.

**The administration fee is R1400 for 2019. If payment is done between 1 September and 30 November 2018, parents can ONLY pay R1180 as an incentive (take note: all outstanding school fees must be paid up to date).**

**A non-refundable administration fee is payable for new AND existing learners for 2019.**

**We are also implementing an Extra Mural fee of R550 for 2019 – This fee will be payable over a period of 11 Months (R50 x 11). This fee will be utilized for all after hour activities, transport to sport/cultural events as well as extra classes presented by Doxa Deo Edendale Independent School NPC.**

**Note: This fee does not include camps and excursions.**

We will ensure that we continue to deliver top quality education, adequately preparing our students to excel in life beyond the classroom! Over and above the quality of the academics on offer, the school continues to excel in sport and cultural spheres, as well as extending our offering in focused Christ centered education to all our students.

We have made every attempt to ensure that the 2019 school fees remain cost effective, yet still allow us to continue to deliver the quality product you have come to expect. The retention of our
